PARTICIPANT AGREEMENT, RELEASE AND ASSUMPTION OF RISK

In consideration of the services of Urban Surf Company, their agents, owners, officers, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to as "Urban Surf"), I hereby agree to release, indemnify, and discharge URBAN SURF, on behalf of myself, my spouse, my children, my parents, my heirs, assist, personal representative and estate as follows:

- 1. I acknowledge that my participation in paddle boarding activities entails known and unanticipated risks that could result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. I understand that such risks Urban Surf simply cannot be eliminated without jeopardizing the essential qualities of the activity.

The risks include, among other things: Being hit by the board, other boarders or their boards which could result in cuts, bruises, abrasions, and concussions; hitting the bottom of the lake/creek; sprains, strains, broken bones, exhaustion, dehydration, and sunburn; accidental drowning; exposure to poisonous and/or carnivorous sea creatures, surf, currents, and tidal conditions; exposure to cold water resulting in hypothermia, cold shock, and accidental drowning; my own physical condition, and the physical exertion associated with this activity. Additionally, fatigue, chill and/or dizziness may diminish my/our reaction time and increase the risk of an accident.

Furthermore, URBAN SURF employees have difficult jobs to perform. They seek safety, but they are not infallible. They might be unaware of a participant's fitness or abilities. They might misjudge the weather or other environmental conditions. They may give incomplete warnings or instructions, and the equipment being used might malfunction.

- 1. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks.
- 2. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless URBAN SURF from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity or my use of URBAN SURF's equipment or facilities, **including any such claims which allege negligent acts or omissions of URBAN SURF.**
- 3. Should URBAN SURF or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.
- 4. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I am willing to assume the risk of any medical or physical condition I may have.

By Urban signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against URBAN SURF on the basis of any claim from which I have released them herein.
